AFWA Webinar The Best Little 2 Hour Federal Tax Update

Join us for our upcoming webinar, The Best Little 2 Hour Federal Tax Update, on January 18 at 12pm EST!

A fast-paced, two-hour federal income tax update that will cover new 2021 tax legislation under the 2021 American Rescue Plan Act and 2021 Infrastructure Investment and Jobs Act. In addition to new 2021 legislation, the update covers tax laws passed in prior years that are still in effect, such as the 2020 Families First Coronavirus Response Act, 2020 CARES Act, COVID Relief Bill CAA 2021, Further Consolidated Appropriations Act 2020, The SECURE Act 2019, the Taxpayer Certainty and Disaster Tax Relief Act of 2019 and the 2018 Tax Cuts and Jobs Act. The update will cover how the various tax laws effect individuals, businesses, estates and trusts and other information for attendees who are tax practitioners or accountants need to know.
