IDEAS FOR DEVELOPING A FRESH PROGRAMMING CALENDAR

Is your Chapter thinking of revamping your Programming Calendar?

There are many elements to consider in a programming calendar from time, day, and location, to CPE or Social, to cost. Varying the elements of your events may appeal not only to your current members, but encourage new members to attend as well.

AFWA minimum standards require only 6 events per year. However, the amount of programming your Chapter holds each calendar year should be based on your Chapter size and amount of volunteer support. Most importantly, don't assume you know what the members of your Chapter want... ask!

In the next few pages, we will provide several templates to consider when developing your Chapter Calendar. Please note – these templates should be used as a starting point for your Chapter's calendar. All topics and dates provided are suggestions. Develop what works best for your Chapter volunteers and members.

MONTHLY NOTES AND TOPIC SUGGESTIONS:

January/February: Many Chapters hold Annual Tax Updates in the early months of the year, providing important information specific to their state. Also, with everyone making (and breaking) New Year's Resolutions, this is a great time for Professional Development topics on Goal Setting or Time Management.

March/April: These month's can be tricky as many members are in the midst of their busy season. Consider hosting a Happy Hour to encourage a break from tax season, or an end of season special event.

May/June/July: This will be the time your Chapter is nominating and installing new leadership. Make announcements during your meetings of open volunteer positions and encourage participation from members. Summer is also a great time for social outings and membership drives.

August/September/October: Back to school season. Invite students for a career planning event or recognize scholarship recipients. This may also be a good season to host a joint event with another local organization.

November/December: The holidays provide a great excuse for a party. Host a holiday social and tie it in with a fundraiser either for your scholarship fund or a local charity.



TRADITIONAL CALENDAR (sample)

Based on the traditional calendar of many chapters, this calendar includes a monthly CPE program with an occasional social event or fundraiser.

Suggestions:

- This calendar is best for Chapters with many active volunteers. A Programming co-chair model will help distribute the work.
- Consider variety in the time, location, and cost of each event.

SEMINAR CALENDAR (sample)

This calendar features a quarterly seminar or workshop that will offer numerous CPE hours on one day. Between seminars, the Chapter will host networking events.

Suggestions:

- This calendar is best for Chapters looking to avoid monthly planning. Consider a different committee or alternating committees for each seminar to spread the work load.
- Fit up to 4 hours into a half day seminar, followed by or kicked off with a networking lunch.
- Promote your seminar dates well in advance to give plenty of planning time for attendees
- Be sure to promote workshops and seminars to the community, these can be great for non-AFWA members to attend.
- Make a distinct difference in registration cost for members and nonmembers to attend each seminar, this will encourage attendees to join AFWA

The premise of this calendar is to host advanced workshops for segments of membership throughout the year. Between each advanced session, professional development and social events will bring the entire membership together.

Suggestions

- Not all events will appeal to all members. But all members will have an opportunity for some quality advanced technical information at some point in the year.
- This calendar appeals to a variety of members and is a great way to bring in topics that appeal to accountants, finance pros, executives and more. Best for Chapters with a lot of members or Chapters looking to grow a particular segment of membership.
- Make a distinct difference in registration cost for members and nonmembers to attend each advanced event, this will encourage attendees to join AFWA

- Designate a Programming Chair for each track and allow each Chair to come up with their own calendar.
- Survey members most likely to attend each track and determine time, date, location that will work best for each
- A good communications plan is very important with this calendar.
