Professor Warfield received a B.S. and M.B.A. from Indiana University and a Ph.D. from the University of Iowa. Professor Warfield's area of expertise is financial accounting. Prior to his academic career, Professor Warfield worked for five years in the banking industry and from 1995-1996 he served as the Academic Accounting Fellow in the Office of the Chief Accountant at the U.S. Securities and Exchange Commission in Washington D.C. While on the Staff, he worked on projects related to financial instruments, financial institutions, and helped coordinate a symposium on intangible asset financial reporting. Professor Warfield served as one of three academic members of the Advisory Council to the Financial Accounting Standards Board (2005-2009) and as a trustee for the Financial Accounting Foundation (2013-2019). Professor Warfield's primary research interests concern financial accounting standards and disclosure policies, including the effects of accounting information and disclosures on securities markets. He has published articles in various scholarly and practice oriented outlets. Professor Warfield teaches intermediate and graduate level courses in financial reporting and he has served on numerous PhD dissertation committees. He has received teaching awards at both the University of Iowa and the University of Wisconsin and he has developed several case studies based on his research for use in accounting classes. These cases and related instructional articles have been published in Issues in Accounting Education and the AICPA Professor-Practitioner Case Development Program. Professor Warfield is co-author (with D. Kieso and J. Weygandt) of Intermediate Accounting, (17th Edition), Intermediate Accounting: Principles and Analysis (2nd Edition), and Intermediate Accounting: IFRS 4 th Edition.
